ORDER

Sri. M.V. Rajan, Exe.Engineer has filed OA(EKM) No.733/2018 before the Hon'ble Kerala Administrative Tribunal aggrieved by the supersession of him in the select list for promotion to the post of Superintendent Engineer by the DPC(H) 2018 which held on 14.12.2017, due to the prevalence of disciplinary action for minor penalty against him in connection with the unauthorised construction of 'Ragam Theatre' in Thrissur Corporation as per the CTP Vigilance recommendation.

2. The Hon'ble Kerala Administrative Tribunal, vide order read as 1st paper above, have disposed of the OA(EKM) 733/2018 directing the Convenor, the DPC(H) to cause disposal of Annexure A7 representation, read as 2nd paper above, after placing it for consideration by an adhoc DPC, as expeditiously as possible, at any rate, within a period of two months from the date of receipt of a certified copy of the order.

3. The request of the applicant in Annexure A7 representation is to convene review DPC(H) meeting and to consider his claim for promotion as Superintending Engineer and include him in the select list. Later, the above disciplinary action was finalised by withholding one annual increment without cumulative effect from his salary, vide GO(Rt)No.1427/2018/LSGD dtd 22.05.2018.

4. The review DPC(H) 2018 which convened on 10.07.2018 in pursuant to the above orders of the Hon' KAT after considering the nature of punishment awarded to the incumbent vide GO dtd 22.05.2018 observed that the applicant is eligible for promotion to the cadre of Superintending Engineer. Hence, the DPC(H) has decided to include him as Sl. No.1(a) by placing him in the first

position of the select list 2018 for promotion to the post of Superintending Engineer and to modify the select list accordingly. Subsequently, the modified select list 2018 has been approved and notified vide GO read as 3rd paper above.

5. In the above circumstances as the applicant has been included in the modified select list 2018 for promotion to the post of Superintending Engineer after considering his review petition, his grievance has been redressed and the order of the Hon'ble KAT in OA(EKM) No.733/2018 read as 1st paper above, has been complied with accordingly.
