**ORDER**

As per the order read as 2<sup>nd</sup> paper above the Hon'ble Kerala Administrative Tribunal has directed the Additional 5<sup>th</sup> Respondent to submit factual report in VC27/15/TSR as expeditiously as possible without further delay and to conclude the proceedings therein within a period of three weeks from the date of receipt of a copy of this order. On conclusion of the above proceedings, the 1<sup>st</sup> Respondent shall consider the claim of the applicant for selection/appointment to the post of Secretary by convening an Adhoc DPC, if so required. This shall be done within a period of two months therefrom.

2. As per the letter read as 3<sup>rd</sup> paper above the Director of Panchayats has informed that the enquiry in VC27/15/TSR has been completed and final report has been submitted before the Hon'ble Vigilance Court, Thrissur, in compliance to the judgment. Being the convenor of DPC(Lower) Director of Panchayath is the competent authority to convene DPC (Lower) . In this circumstance Government have examined the matter in detail and are pleased to direct the Director of Panchayats to convene Adhoc DPC for considering the claim of Sri. Subramanian for selection/appointment to the post of Secretary Grama Panchayat, as the Director of Panchayats is the Convenor of the DPC.

3. The order of the Hon'ble Kerala Administrative Tribunal read as 2<sup>nd</sup> above is thus complied with.
