ORDER

As per Government Orders read as 1st and 2nd paper above, Government have constituted a State Level Advisory Committee (SLAC) chaired by the Chief Secretary to coordinate the implementation of investible projects in the waste management sector and to take key decisions in this regard.

- 2. As per Government Order read as 3rd paper above, Government have accorded sanction for establishing 5MW solid Waste-to-Energy (WtE) plants on Design, Build, Finance, Operate and Transfer (DBFOT) basis in Public-Private-Partnership (PPP) mode at 7 sites, one each in Thiruvananthapuram, Thrissur, Palakkad, Kozhikode, Kannur, Kollam and Malappuram Districts.
- 3. The State Level Advisory Committee (SLAC), at its 12th meeting held on 11.07.2018 had decided to constitute a Bid Evaluation Committee comprising the following members for responding to the queries likely to be raised by the prospective bidders as well as for evaluation of technical bids in connection with selection of bidders for establishing Waste to Energy plants in the State.

 - iii) Director, Urban Affairs Member
 - iv) Director, Generation (Electrical), KSEB Ltd Member

 - vi) Shri. R. Sridhar, CA (Financial Expert) Member
 - vii) Technical Expert (to be nominated by Higher Education Department) Member

Government have examined the matter in detail and are pleased to constitute a Bid Evaluation Committee as detailed above for clarifying the doubts and queries likely to be raised by the prospective bidders at the pre - bid meeting and also for evaluation of pre- qualification and technical bids in connection with selection of bidders for establishing Waste to Energy plants in the State .
