As per the Sanction Order read as 2nd above, Government of India, Ministry of Rural Development has sanctioned an amount of Rs. 77,20,000 as 1st installment of Administrative Fund to the State Government under Pradhan Mantri Gram Sadak Yojan( PMGSY) for the year 2018 – 19. The funding pattern for PMGSY between Central and State Government is 60:40. As per the letters read as 3rd paper above the Member Secretary, KSRRDA has requested to release the Central Share received from Government of India along with the corresponding State Share of Rs.51,46,667/- to the PSTSB account of Commissioner for Rural Development & Memeber Secretary, KSRRDA at District Treasury, Thiruvananthapuram .
