ORDER

As per G.O read as 3rd paper above Government have accorded Administrative Sanction for an amount of **Rs. 72.08 Crore** under H/A 2217-05-192-70 and H/A 2217-05-191-71 for the implementation of various components under SBM(U) - Centrally Sponsored Scheme for the year 2018-2019.

Government of India have released an amount of Rs. 2999.25 Lakh for the component of Solid Waste Management and Rs.96 Lakh for the component of Capacity Building and Office Expenses under Swachh Bharat Mission (Urban) for the year 2018-19.

As per the letter read as 5th paper above, the Executive Director, Suchitwa Mission has requested to accord sanction for releasing the Central Share along with matching State Share (in the ratio of 60:40) for the implementation of Swachh Bharath Mision(Urban) for the year 2018-19, with permission to Executive Director, Suchitwa Mission to draw the amount to the Suchitwa Mission Account.

Government have examined the matter in detail as per the guidelines issued in the G.O. read as 4th paper above and are pleased to accord sanction for the release of **Rs.4998.75 Lakh** under **H/A 2217-05-192-70** and **Rs.160 Lakh** under **H/A 2217-05-191-71** (for Municipal Corporation) and **H/A 2217-05-192-70** (for Municipalities) as Central and State Share for the components of Solid Waste Management and Capacity Building & Office Expenses, under Swachh Bharat Mission (Urban) for the year 2018-2019 as detailed below.
