### **ORDER**

As per the letter read as 1<sup>st</sup> paper above Ministry of Housing and Urban Affairs, Government of India have informed that 35 Training Entities have been shortlisted for rolling out Integrated Capacity Building framework covering all Urban Missions viz. AMRUT, Swachh Bharat Mission (SBM), Smart Cities Mission (SCM), National Urban Livelihood Mission (NULM), Housing for All (HFA), Pradhan Mantri Awas Yojna (PMAY) and HRIDAY for Urban Local Body functionaries and elected representatives.

All India Institute of Local Self Government (AIILSG), Centre for Environment and Development (CED), Trivandrum, Kerala Institute of Local Administration (KILA) Thirur, and Institute of Management in Government (IMG), Trivandrum are the four organization from Kerala, which are included in the Training Entities shortlisted by Ministry of Housing and Urban Affairs. It was also informed that the necessary funds for roll out of the integrated Capacity Building plan will be made available from on going Capacity Building for Urban Development (CBUD) project of the Ministry of Housing and Urban Affairs supported by the World Bank.

3. As per the letter read as 2<sup>nd</sup> paper above Executive Director Suchitwa Mission has requested to entrust Director of Urban Affairs to enter into a Memorandum of Understanding with Training Entities on behalf of Government of Kerala, for carrying out Integrated capacity building covering all missions and to entrust Kerala Institute of Local Administration (KILA) to work out the modality and appropriate plan for rolling out the training.

4. Government have examined the matter in detail and are pleased to Order as follows:

- i. Director KILA is entrusted to work out the modality and appropriate plan for rolling out said training
- ii. Director of Urban Affairs and KILA are entrusted to do a training need assessment
- iii. KILA shall co-ordinate with Government of India and shortlisted agencies for the training programmes, training schedule etc.
- iv. Director of Urban Affairs is entrusted to enter in to a Memorandum of Understanding with Training Entities on behalf of Government of Kerala.
