ORDER

As per the G.O. Read as 1<sup>st</sup> paper above Smt.Lekha C.S., Executive Engineer was transferred from PIU, Thrissur to the O/o the Superintending Engineer, South Circle, Thiruvananthapuram in place of Sri.Syam G., who is transferred to Thrissur Corporation. Sri.Charles A.L., Executive Engineer was transferred from Kollam Corporation to PIU, Thrissur in place of Smt.Lekha C.S. Against the above transfer Sri.Syam G., Executive Engineer has filed OA(EKM) 453/2018 before Hon'ble KAT and obtained a stay order against his transfer, as per the interim order of honorable Kerala Administrative Tribunal, read as 2<sup>nd</sup> paper above. Therefore even though Smt.Lekha C.S. was relieved from PIU, Thrissur, she could not join South Circle, Thiruvananthapuram due to the stay ordered in favor of Sri.Syam G. It was also directed in the above order that since Smt.Lekha C.S. could not join back PIU, Thrissur as Sri.Charles A.L had already joined there, she shall be accommodated in any existing vacancy, if available, at Thiruvananthapuram or in the O/o the CE, LSGD, without any break in service.

2.While the case was under consideration of the Government, the Hon'ble KAT set aside the G.O. Read as 1<sup>st</sup> paper above to the extent it transfers

Sri.Syam G. from the South Circle Office, Thiruvananthapuram per the final order read as 3<sup>rd</sup> paper above. It is also ordered to retain him at the above station, subject to finalisation of the general transfer 2018. It was further directed to repost Smt.Lekha C.S. back to PIU, Thrissur and to ensure that no break in service is caused due to the transfer and reposting of Smt.Lekha C.S. But, since Sri.Charles A.L. has already joined PIU, Smt.Lekha C.S. could not be posted back. Therefore, as per the G.O. read as 4<sup>th</sup> paper above she was accommodated in the vacancy arose at Thiruvananthapuram Corporation.

3.The Chief Engineer, as per the letter read as 5<sup>th</sup> paper above, has informed that the incumbent joined Thiruvananthapuram Corporation on the FN of 05.04.2018 and is currently working there. There existed a vacancy of Executive Engineer in the department during the period of waiting for posting in respect of Smt.Lekha C.S.

5. In the aforesaid circumstances, the period of waiting for posting from 17-02-2018 to 04-04-2018 in respect of Smt.Lekha C.S., Executive Engineer is regularised as duty under Note 4 below Rules 12 (7), Part I, Kerala Service Rules.
