ORDER

In the Government order read as first paper above Smt.L.S.Deepa, Municipal Secretary Grade 1 was promoted to the cadre of Corporation Secretary/Additional Corporation Secretary, and posted as Additional Corporation Secretary, Kollam and she joined duty on the F.N of 30.09.2015.

The Director of Urban Affairs vide letter read as second paper above have recommended and forwarded the application submitted by Smt.L.S.Deepa, for the declaration of probation in the cadre of Corporation Secretary /Additional Corporation Secretary, along with Work and Conduct Certificate and Self appraisal report of the incumbent. It was also reported that three cases of disciplinary actions were pending against the incumbent. Since disciplinary action was pending her probation in that category has not declared.

The incumbent then filed OA 3083/2017 and Q.A 276/2018 before the Hon'ble Kerala Administrative Tribunal and Hon. Tribunal in the order dated 25/09/2018 has directed Government to issue orders declaring the probation of the applicant on or before 10/10/2018.

Government have examined the matter in detail. In compliance of the earlier orders of the Hon'ble Administrative Tribunal, all the three disciplinary cases pending against the incumbent have been finalized vide G.O(Rt)No1863/2018/LSGD dated 06/07/2018, G.O(Rt)No 2287/2018/LSGD dated 19/08/2018 and G.O(Rt)No 2304/2018/LSGD dated 21/08/2018.

Period of probation in the category of Corporation Secretary/Additional Corporation Secretary is six months duty within a continuous period of one year. She joined duty in

this cadre on the F.N of 30.9.2015. It is reported that she had not availed any kind of leave other than casual leave during the period of probation. No vigilance case or disciplinary action is pending against her.

In the circumstances Government are pleased to declare that Smt.Deepa.L.S. has satisfactorily completed the period of probation in the cadre of Corporation Secretary /Additional Corporation Secretary with effect from 30.03.2016 FN as per Rule 20 (b) of General Rules of KS&SSRs.

The Hon: ble Tribunal's order in OA 3083/2017 and O.A 276/2018 dated 25/09/2018 is thus complied with.
