### ORDER

As per Government order read as first paper above, Sri. T.V. George (Rtd. Joint Development Commissioner ) was appointed as Exe. Director, formerly AHADS-CCPRM. But the terms and conditions of appointment were not mentioned in the said order. As per Government order read as second paper above, he was relieved of his duties.

2)Later Sri. T.V. George filed O.A.No: 1476/17 before the Hon'ble Administrative Tribunal for disbursement of pending salary and travelling allowance. The Hon'ble Administrative Tribunal in its order dated 31.07.2017 in O.A.No. 1476/17 has ordered the first respondent i.e. Secretary, LSGD to take a decision on Annexure A.10 representation (Request dated 10.07.2017 of the applicant before the Principal Secretary) to sanction and disburse the salary for the period from 06.01.2016 to 10.08.2016 (the period he worked as Executive Director, AHADS-CCPRM) within a period of two months from the date of receipt of a certified copy of the order.

3)There was a further direction to the second respondent (i.e. Mission Director and CRD, MGNREGS, Kerala State Mission) to take a decision on Annexure A9 representation (Request dated 10.07.2017 of the applicant before the Mission Director, MGNREGS Kerala) containing the request for release of honorarium and eligible travelling allowance for the period he had worked as Consultant at MGNREGA Mission, as early as possible, at any rate, within a period of one month from the date of receipt of a certified copy of the order.

4) Since the order was not complied with within the stipulated time, the applicant has preferred the Contempt of Court proceedings as per letter read as 4<sup>th</sup> paper above.

5) Government have examined the matter in detail. It was observed that the terms and conditions of appointment were not mentioned in the Government order read as first paper above which caused inordinate delay in complying with the order of the Hon'ble Administrative Tribunal. Hence as per Government order read as 5<sup>th</sup> paper above, it has been ordered to treat the appointment as Contract basis. Direction has been given to Commissioner of Rural Development to take necessary steps to disburse the arrear to Sri.T.V.George.


6) Regarding the direction to the second respondent i.e. Mission Director, MGNREGS, Kerala, it is hereby ordered that Mission Director, MGNREGS, Kerala shall examine and dispose of the pending request dated 10.07.2017 of the petitioner before the Mission Director, MGNREGS Kerala at the earliest. Accordingly, the directions of the Hon'ble Administrative Tribunal are complied with.
