ORDER

The DPC(H) 2017 held on 24.10.2017 superseded Smt. Beena Narayanan, Sri. Vinayadas. N.A, Sri. Baburaj. B.R, Sri. Bicini. S and Sri. Ashraf Khan, among others for promotion to the post of Asst.Exe.Engineer due to the non declaration of probation in the entry cadre of Assistant Engineer / prevalence of disciplinary actions. As such, the select list of Asst. Engineers 2017 was published as per GO read as 1st above without including the above incumbents. However, subsequently they have become eligible for promotion to the cadre of Assistant Executive Engineer and accordingly, select list 2017 was later modified as per Government Order read as 3rd paper above, after convening adhoc DPC(H) 2017 on 27.02.2018; by including the above officials in the serial positions 17a, 22a, 31a, 46a & 46b respectively, just above their immediate juniors.

2. Pursuant to the modified select list 2017, Smt. Beena Narayanan and Sri. Vinayadas. N.A, Asst.Engineers were promoted as Asst.Exe.Engineer as per GO(Rt)No. 959/2018/LSGD dtd 04.04.2018. Sri. Baburaj. B.R and Smt. Bicini. S were promoted as Asst.Executive Engineers as per GO(Rt)No.1564/2018/LSGD dtd 07.06.2018, whereas Sri. Ashraf Khan was promoted as Asst.Exe.Engineer as per GO(Rt)No.2239/2018/LSGD dtd 13.08.2018. The immediate juniors of all these officials in the modified select list 2017 were already promoted as Asst.Exe.Engineer as per GO read as 2nd paper above. Accordingly, the Chief Engineer, as per letter read as 4th paper above, has proposed to promote all the above incumbents notionally to the cadre of Assistant Executive Engineer w.e.f date of promotion of their immediate juniors, ie 07.11.2017.

3. Government have examined the matter in detail and are pleased to notionally promote Smt. Beena Narayanan, Sri. Vinayadas. N.A, Sri. Baburaj. B.R, Sri. Bicini. S and Sri. Ashraf Khan, Asst.Exe. Engineers to the cadre of Asst.Exe.Engineer w.e.f the date of promotion of their immediate juniors, ie 07.11.2017, without monetary benefit of back arrears of pay and allowances.
