ORDER

The DPC(H) 2018 held on 14.12.2017 superseded Sri. M.V. Rajan, Smt. P.G. Girija Devi and Sri. P.J. Ajayakumar, among others for promotion to the post of Superintending Engineer due to the prevalence of disciplinary actions. As such, the select list of Executive Engineers 2018 was published as per GO read as 1st above without including the above incumbents. However, subsequently they have become eligible for promotion to the cadre of Superintending Engineer and accordingly, select list 2018 was later modified as per Government Order read as 4th paper above, after convening adhoc DPC(H) 2018 on 10.07.2018; by including the above officials in the serial positions '1a', '1b' & '2a' respectively.

2. Pursuant to the modified select list 2018, Sri. M.V. Rajan and Smt. P.G. Girija Devi Executive Engineers were promoted as Superintending Engineer as per GO read as 5th paper above, whereas, Sri. P.J. Ajayakumar, Exe.Engineer was promoted as Superintending Engineer vide GO read as 6th paper above. The immediate juniors of Sri. M.V. Rajan and Smt. P.G. Girija Devi, and Sri. P.J. Ajayakumar in the modified select list 2018 were already promoted as Superintending Engineer as per GO read as 2nd & 3rd papers above respectively. Accordingly, the Chief Engineer, as per letter read as 7th paper above, has proposed to promote Sri. M.V. Rajan and Smt. P.G. Girija Devi, notionally to the cadre of Superintending Engineer on 04.04.2018 and in the case of Sri. P.J. Ajayakumar on 07.06.2018 ie, w.e.f date of promotion of their immediate juniors.

3. Government have examined the matter in detail and are pleased to notionally promote Sri. M.V. Rajan and Smt. P.G. Girija Devi (Rtd.) to the cadre of

Superintending Engineer on 04.04.2018 and in the case of Sri. P.J. Ajayakumar on 07.06.2018, ie, w.e.f date of promotion of their immediate juniors, without monetary benefit of back arrears of pay and allowances.
