ORDER

The DPC(H) 2017 held on 24.10.2017 superseded Smt. Neetha Kambil and Smt. Shaiby George, AEEs for promotion to the post of Exe. Engineer due to the prevalence of disciplinary action for major penalties against them. As such, the select list of Assistant Executive Engineers 2017 was published as per GO read as 1<sup>st</sup> above without including the above incumbents. However, subsequently they have become eligible for promotion to the cadre of Executive Engineer and accordingly, select list 2017 was later modified by including Smt. Neetha Kambil as '1a' and Smt. Shaiby George as '5a' in the select list, vide Government Orders read as 3<sup>rd</sup> and 4<sup>th</sup> papers above respectively, after convening Review DPC(H)s on 14.12.2017 and 27.02.2018.

2. Pursuant to the modified select list 2017, Smt. Neetha Kambil and Smt. Shaiby George, Asst.Exe.Engineers were promoted as Executive Engineers as per GO read as 5th paper above. The immediate junior of both the officials in the modified select list 2017 were already promoted as Executive Engineer as per GO read as 2<sup>nd</sup> paper above. Accordingly, the Chief Engineer, as per letter read as 6<sup>th</sup> paper above, has proposed to promote Smt. Neetha Kambil and Smt. Shaiby

George, notionally to the cadre of Executive Engineer on 06.11.2017 ie, w.e.f date of promotion of their immediate juniors.

3. Government have examined the matter in detail and are pleased to notionally promote Smt. Neetha Kambil and Smt. Shaiby George to the cadre of Executive Engineer on 06.11.2017 ie, w.e.f date of promotion of their immediate juniors, without monetary benefit of back arrears of pay and allowances.
