**ORDER**

Smt.Tharakumari G., D/o Late Gomathy Amma G., who died in harness on 24/07/2015 while working as Part Time Sweeper in O/o the Superintending Engineer, South Circle, Thiruvananthapuram, has applied for employment assistance under Compassionate Employment Scheme as per the application read as 3<sup>rd</sup> paper above. The application was submitted within the prescribed time limit. The deceased Government servant had put in a total service of 28 years 6 Months and 7 days.

2. The date of birth of the applicant is 10/05/1974. She has passed SSLC

Examination. The request is for appointment in the post of Sweeper. As the applicant is 44 years old, at present the applicant is qualified for only part-time job.

3. The Chief Engineer, LSGD, Thiruvananthapuram and the District Collector, Thiruvananthapuram as per the letters read as 4<sup>th</sup> and 5<sup>th</sup> papers above have recommended the request of Smt.Tharakumari G. All the other legal heirs of the deceased have given their consent for providing employment to Smt.Tharakumari G. The applicant is the daughter of the deceased. The annual family income of the applicant is ₹48,000/- (Rupees Forty Eight thousand only). The Tahasildar, Thiruvananthapuram has certified that the applicant was a dependent of the deceased Government servant even after her marriage, as per paper read as 6<sup>th</sup> above.

4. In the circumstances, Government are pleased to accord sanction for the appointment of Smt.Tharakumari G, D/o Late Gomathy Amma as Part Time Sweeper in the Local Self Government (Engineering Wing) Department in Thiruvananthapuram District in the existing or next arising vacancy under the Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1<sup>st</sup> and 2<sup>nd</sup> paper above. Necessary entries in this regard will be made in the Service Book of the deceased Government servant and also in the Establishment Register of the office where the deceased employee last worked and the entries will be attested by the Head of Office/Head of Department.

5. The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of inquiry conducted by the Department in which she is appointed.

6. The Chief Engineer, Local Self Government Department, Thiruvananthapuram will issue necessary posting orders to Smt.Tharakumari G, after verification of the original documents produced by her to prove age, educational qualification, medical fitness and after confirming the genuineness of the same and also subject to other conditions under the scheme in force.
