ORDER

The 14th Finance Commission recommended an amount of ₹1739.56 crore as Finance Commission Grant to the Local Governments for the year 2018-19. Out of this, an amount of ₹650.84 crore and ₹184.69 crore have been earmarked for the Urbanl Local Governments as Basic Grant and Performance Grant respectively. Authorization of Finance Commission Grant to Local Governments for expenditure is usually made only against the release of the same from Government of India. But in order to clear the bills in the Treasury queue and to meet the expenditure of spill over projects, vide Government order read as 3rd and 4th papers above, authorized an amount of ₹216,94,66,667/- and ₹3,26,736/- respectively as Basic Grant to Municipalities and Municipal Corporations under 14th Finance Commission for 2018-19. As per Government order read as 5th paper above, an amount of ₹108,44,06,597/- being the balance amount of 1st instalment Basic Grant has been authorized to Urban Local Governments against the release of 1st instalment of Basic Grant from Government of India.

- 2. As per order read as 6th paper above, Government of India have released an amount of ₹325,42,00,000/- (Rupees Three hundred and Twenty Five crore Forty Two lakh only) as 2nd installment of Basic Grant under 14th Finance Commission Award to Urban Local Governments for the year 2018-19.
 - 3. Under these circumstances, the following orders are issued:
 - a) Authorization for 2nd installment of Basic Grant under14th Finance Commission Award amounting to ₹325,42,00,000/- (Rupees Three hundred and Twenty Five

crore Forty Two lakh only) is issued to the Urban Local Governments as detailed below:

- b) This authorization is exempted from all treasury restrictions.
- c) Director of Treasuries shall make available copies of this order to the District / Sub Treasuries through Treasury intranet.
- d) Secretaries of Local Governments shall draw the amount by producing fully vouched contingent bills.
- e) Treasury officers shall ensure that the contingent bills presented under 14th Finance Commission Grant from a Local Government should not exceed the authorization.
