ORDER

An amount of Rs.15 Crore has been earmarked under the Head of Account 2217-05-051-98(p) for "Construction of Office Building for Newly formed Municipalities". The Special Working Group held 19.12.2018 has approved the proposal for Construction of Office Building for Newly formed Municipalities for an amount of Rs.12 Crore (20% plan cut effected) subject to the condition that, an amount of Rs.3 crore each should be allocated on priority basis to 4 eligible Municipalities that submit Detailed Project Report based on prefab design technology with detailed estimates (DSR 2016) prepared on 'PRICE' software.

- 2. The Chairmen/Chairperson of Piravom, Ettumanoor & Harippad Municipalities and the Secretary, Wadakkanchery Municipality have informed their willingness to construct office building based on prefab design technology.
- 3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the project "Construction of Office Building for Newly formed Municipalities" for an amount of Rs.12 Crore under H/A 2217-05-051-98(p) subject to the following condition :
 - An amount of Rs.3.00 Crore each should be allocated on priority basis to Piravom, Ettumanoor, Wadakkanchery & Harippad Municipalities those expressed willingness to construct office building based on prefab design technology.

- ii. The Municipalities should submit DPRs based on prefab design technology with detailed estimates (DSR 2016) prepared on 'PRICE' software.
- iii. The fund release will be based on actual requirement and the fund released should not be parked in Banks.
- iv. Store Purchase Rules shall be strictly adhered to.
- v. Tender/e-tender and other stipulated formalities shall be followed where ever necessary.
- vi. For civil works, CPWD rates shall be followed.
