#### **ORDER**

As per the G.O. read as 1st paper above, sanction was accorded to Kudumbashree for imparting training to Mayors/Chairpersons, Secretaries and Officers in charge of PMAY(U) at India Institute of Human Settlements, Bengaluru as part of the comprehensive capacity building programme of Ministry of Housing and Urban Affairs subject to the condition that, travelling expenses in connection with the training shall be met from the Administrative Cost of PMAY(U) as per the eligibility of the participants.

- 2.As per the letter read as 2nd paper above, the Executive Director, Kudumbashree has reported that, eventhough there is a Capacity Building Plan and IEC Plan under PMAY for payment of honorarium, geotagging, workshop and IEC Activities, , there is no fund for meeting the travelling expenses under PMAY. The Executive Director has therefore requested to accord sanction to meet the travelling expenses of the participants attending the aforesaid comprehensive capacity building programme from the own fund of Urban Local body, as per eligible T.A. Norms.
- 3. Government have examined the matter in detail. As per the guidelines of comprehensive capacity building programme of Ministry of Housing and Urban Affairs, the training expenses other than travelling expenses will be borne by the Ministry. Therefore sanction is accorded to
