### ORDER

As per GO read as 3<sup>rd</sup> paper above Government have accorded sanction for setting up of Integrated Waste-to-Energy(WtE)Plants in 7 Districts (Thiruvananthapuram, Kollam, Thrissur, Palakkad, Malappuram, Kozhikkode & Kannur) on Design, Build, Finance, Operate and Transfer (DBFOT) basis, in Public-Private-Partnership (PPP) mode. The land in possession of Kannur Corporation at Chelora Village is one of the proposed sites for setting up the Waste-to-Energy (WtE) Plant.

2. As per G.O read as 1<sup>st</sup>&2<sup>nd</sup> paper above Government have constituted a State Level Advisory Committee (SLAC) chaired by Chief Secretary, for taking decision on the setting up of centralized Solid Waste Management Plants and co-ordinating the further activities towards to this end. As resolved in the SLAC, a stake holder meeting with respect to the setting up of Integrated Waste-to-Energy Plant at Chelora in Kannur District was held on 14/12/2018 in the office of District Collector, Kannur. In the stake holder meeting the Mayor and Councillors of Kannur Corporation expressed their interest to visit a similar Waste-to-Energy Plant in India to understand the operation and effectiveness of the solid waste processing in Waste-to-Energy Plants. The Council meeting of Kannur Municipal Corporation held on 5<sup>th</sup> January 2019 has resolved to send a 15

member delegation comprising Mayor, Dy. Mayor, Standing Committee Chairperson / Chairmen, Councillors and Officials to visit an efficient Waste-to-Energy plant in India.

3. As per the minutes read as 4<sup>th</sup> paper above, the SLAC has entrusted the Managing Director, Kerala State Industrial Development Corporation (KSIDC) to take necessary steps to arrange the visit of the 15 number delegation to the Waste-to-energy plant at Jabalpur.

4. As per the letter read as 5<sup>th</sup> paper above Managing Director, KSIDC has requested to accord sanction for the visit of the following 15 number delegation from Kannur Municipal Corporation to the Waste-to-Energy plant at Jabalpur with permission to meet the expenditure in connection with the visit of the delegation from the fund allotted to KSIDC for the implementation of Urban Solid Waste Management Initiative.
