The Mission Director, MGNREGS vide letter read as 3rd paper above has submitted a proposal for releasing the central share received along with corresponding state share.

Government have examined the matter in detail and are pleased to accord sanction to release an amount Rs.6,97,00,000/-(Rupees Six Crore Ninety Seven Lakh Only) being the 2nd part of 2nd tranche of Central Assistance received from Gol towards Material and Administrative components of MGNREGA and an amount of Rs.1,03,33,000/-(One Crore Three Lakh and Thirty Three Thousand only) as corresponding state share of Material component for the financial year 2018-19, as detailed below:
