ORDER

On advise of Kerala Public Service Commission, Government had appointed Smt.Beena.S.Kumar as Municipal Secretary Grade-III at Iringalakkuda Municipality as per the Government Order read as 1st paper above. The officer joined duty at Iringalakkuda Municipality on 18/09/2014 FN. The Director of Urban Affairs, as per the letter read as 3rd paper above, has reported that no disciplinary proceedings/vigilance case is pending against the incumbent during the period of probation and that the work and conduct of the incumbent is good. It is also reported that, the normal period of declaration of probation in the cadre of Municipal Secretary Grade III is two years of duty, within a continuous period of three years. But the incumbent has passed the municipal test prescribed for the declaration of probation in the cadre of Municipal Secretary Grade III, only on 23/08/2017. Hence, the Director has recommended to extend the period of probation of the incumbent up to 23/08/2017 AN and declare the same with effect from the FN of 24/08/2017.

The Director has informed that, the incumbent has not availed any leave other than casual leave during the period of probation. As per the Government Order read as 2nd paper above, the appointment of

Smt.Beena.S.Kumar, Secretary, Iringalakkuda Municipality in the cadre of Municipal Secretary Grade-III was regularised with effect from 18/09/2014.

Government have examined the matter in detail and are pleased to extend the period of probation in respect of Smt.Beena.S.Kumar, Secretary, Iringalakkuda Municipality up to 23/08/2017 as per Rule 21 of General Rules of KS&SSRs, and are also pleased to order that, Smt.Beena.S.Kumar, Secretary, Iringalakkuda Municipality has satisfactorily completed the prescribed period of probation in the cadre of Municipal Secretary Grade-III with effect from 24/08/2017 FN as per Rule 20 (b) of General Rules of KS&SSRs.
