ORDER

As per G.O read as 1st paper above, an amount of Rs.71.84 Lakhs has been sanctioned to District Collector, Idukki for removing the flood waste spread over the agriculture land of a private individual from the dumping yard of Kumily Grama Panchayat and transferring the same to Kerala Enviro Infrastructure Ltd (KEIL), Ambalamukal for safe land filling. Accordingly the District Collector, Idukki has entrusted Clean Kerala Compnay Ltd (CKCL) to transfer the waste from Kumily to KEIL, Ambalamukal. CKCL has invited competitive bids from the transport operators through proper channel. Out of the 5 bids received Mr. Afsal, A&A construction has quoted an amount of Rs. 2,199/- per tonne, the lowest bid for the transfer of flood waste from Kumily to KEIL (including the cost of labour and machinery for loading the waste in trucks). Considering the fact that the amount quoted by Mr. Afsal, A&A construction is reasonable compared to market rate and the second lowest bid amount is Rs.4739 /-, Managaing Director, Clean Kerala Compnay Ltd has issued the work order to Mr. Afsal, A&A construction, the lowest bidder in view of the urgency to complete the work before March 31st, 2019 and forthcoming of monsoon.
