ORDER

As per the Govt. Order read as 1st paper above, Revised Administrative Sanction had been accorded for the Construction of Swaraj Bhavan in Sy.No.3038 of Vanchiyoor Village, Thiruvananthapuram for an amount of Rs. 17,05,58.549/-. The Agreement was executed at 14.28% above estimate rate based on the SoR 2008. The work was completed on May 2013.

2. As per letters dated 09/12/2015 & 27/11/2017 read as 2nd paper above, the Chief Engineer has reported that a total amount of Rs.1,07,49,143/-is pending for payment to the Contractor, since 2013. Eventhough direction has been given to the Contractor to rectify the defects in ACP work, he has not done the rectification works for the reason that, guarantee period of the construction is over. As the cost of ACP work comes to Rs.34,89,664/-and the Contractor is bound to rectify the defects in ACP works, the Chief Engineer has requested to deduct this amount (cost of ACP work) from the final bill due to the Contractor. Thus the net payment due to the Contractor is Rs.72,59,479/-[Rs.1,07,49,143 - Rs.34,89,664]

3.The Commissioner for Rural Development as per letter read as 3rd paper above has submitted necessary proposal for allocating Rs.72,59,479/-under the H/A 4515-00-103-99(01) Construction of Swaraj Bhavan- Works (Plan) through Supplementary Demands for Grants for settling the payment to the Contractor towards Construction of Swaraj Bhavan. As per the final batch of Supplementary Demands for Grants for 2018-19, an amount of Rs.72,60,000/- has been allocated under the H/A 4515-00-103-99(01) Construction of Swaraj Bhavan-Works (Plan) for the above purpose.

4. In the above circumstance, Government are pleased to accord sanction to release an amount of Rs.72,59,479/- to the Commissioner for Rural Development from the Head of Account "4515-00-103-99(01) Construction of Swaraj Bhavan-Works (Plan)" for payment of final bill amount to the Contractor towards the Construction of Swaraj Bhavan.
