ORDER

As per G.O. read as 1st paper above Kudumbashree has been authorized to organize SARAS Fairs in the State in association with Rural Development Department.

As per the minutes read as 2nd paper above it has been decided to organize the 2nd SARAS Fair 2018-19 at Kunnankulam, Thrissur from 28th March to 7th April 2019 as a joint programme of Ministry of Rural Development, Kudumbashree and District / Block / Grama Panchayats of Thrissur. Women entrepreneurs from all over India who are part of SHGs under SGSY/NRLM will be participating in the fair to exhibit and sell their SHG products. It is a regular programme being implemented in State every year under NRLM and SARAS Fair, 2019 has actually started on the ground after obtaining all necessary sanctions. Stalls were already allotted to women entrepreneurs from across the Country. The Executive Director, Kudumbashree as per letter read as 4th paper above has therefore requested to accord sanction to conduct the SARAS Fair, 2019 at Kunnankulam, Thrissur with the necessary approval from State Election Commission since the Model Code of Conduct (MCC) come into effect from 10.03.2019 in connection with the General Election to Lok Sabha 2019. Further, as per the Note read as 3rd paper above, the Executive Director, Kudumbashree has requested to accord permissive sanction to District/Block/Grama Panchayath of Thrissur District and Kunnankulam Municipality to contribute an amount of Rs.5 Lakhs, Rs.2 Lakhs, Rs.5000/- and Rs.5 Lakhs respectively towards the conduct of SARAS Fair, 2019 as done in previous years.

2. Government have examined the matter in detail and are pleased to accord sanction to conduct the SARAS Fair, 2019 at Kunnamkulam, Thrissur from 28th March to 7th April, 2019 subject to the following conditions :

- No public inaugural function shall be conducted
- No public men (Minister, MLA, MP, Elected representatives etc.) shall be invited/participated in the Fair.
- Canvassing for election by any candidate or political party shall not be allowed in the fair area and premises.

3. Permissive sanction is also accorded to Corporation, Municipalities, District Panchayath, Block Panchayaths and Grama Panchayaths of Thrissur District to contribute fund to Kudumbashree District Mission, Thrissur for the conduct of SARAS, 2019 as detailed below :

- (i). Thrissur Corporation/District Panchayath, Thrissur / Municipalities of Thrissur District- Rs.5 Lakhs each
- (ii). Block Panchayths of Thrissur District - Rs.2 Lakhs each
- (iii) Grama Panchayaths of Thrissur District - Rs. 5,000/- each.
