ORDER

Smt.Aruna A., D/o Late Andavan K., who died in harness on 14/05/2016 while working as Overseer Grade III in Palakkad Municipality has applied for employment assistance under Compassionate Employment Scheme as per the application read as 3rd paper above. The application was submitted within the prescribed time limit. The deceased Government servant had put in a total service of 34 years 2 Months and 8 days.

- 2. The date of birth of the applicant is 28/03/1986. She has passed SSLC Examination. The request is for appointment in the post of Clerk in Palakkad District and she is qualified for that post.

Palakkad as per the letters read as 4th and 5th papers above have recommended the request of Smt.Aruna K. All the other legal heirs of the deceased have given their consent for providing employment to Smt.Aruna K. The applicant is the daughter of the deceased. The annual family income of the applicant is ₹36,000/- (Rupees Thirty Six thousand only). The Tahsildar, Palakkad, as per paper read as 6th above has certified that the applicant was a dependent of the deceased Government servant even after her marriage.

- 4. In the circumstances, Government are pleased to accord sanction for the appointment of Smt.Aruna K, D/o Late Andavan K. as Clerk in the Local Self Government (Engineering Wing) Department in Palakkad District in the existing or next arising vacancy under the Compassionate Employment Scheme, subject to the conditions laid down in the Government Order read as 1st paper above. Necessary entries in this regard will be made in the Service Book of the deceased Government servant and also in the Establishment Register of the office where the deceased employee last worked and the entries will be attested by the Head of Office/Head of Department.

The employment assistance ordered under the scheme will be cancelled if and when Government find that there was any suppression or misrepresentation of material facts on the part of the applicant at the time of forwarding the application or during the course of inquiry conducted by the Department in which she is appointed.
- 6.The Chief Engineer, Local Self Government(EW)Department, Thiruvananthapuram will issue necessary posting orders to Smt.Aruna K., after verification of the original documents produced by her to prove age, educational qualification, medical fitness and after confirming the genuineness of the same and also subject to other conditions under the scheme in force.
