ORDER

As per Government Orders read as 2nd & 3rd paper above, sanction was accorded to release of an amount of ₹12,89,41,333/- to Kudumbasree towards the second installment of state share for the implementation of Start up Village Entrepreneurship Programme (SVEP) for promotion of enterprise based livelihood in the 12 blocks identified for the purpose (for conducting baseline and market potential study) during the financial year 2018-19. But due to unavailability of sufficient fund, the amount sanctioned was not credited to the Account of Kudumbashree during the financial year 2018-19. Now the Executive Director, Kudumbasree as per his letter read as 4th paper above has requested to release the aforesaid amount from the current year's Budget allocation.

After having examined the matter in detail, Government are please to accord sanction to release an amount of ₹12,89,41,333/-(Rupees Twelve Crore Eighty Nine Lakh Forty One Thousand Three Hundred and Thirty Three Only) towards the 2nd installment of State Share in respect of Annual Action Plan (AAP) under Start up Village Entrepreneurship Programme (SVEP) for promotion of enterprise based livelihood in the 12 blocks identified for the purpose, for conducting baseline and market potential study, from the current year's (2019-20) Budget Provision under the Head of Account 2501-06-197-48 (04).
