**ORDER**

As per Government Order read as 1<sup>st</sup> paper above, sanction has been accorded to release an amount of ₹97.75 Crore to KSRRDA, as 1<sup>st</sup> instalment of Central Share of Programme Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19 along with the matching State Share of ₹65.17 Crore from the H/A 4515-00-800-98(01) and 4515-00-800-98(02) respectively. But only 50 Crores from the Central Share has been released to KSRRDA during the financial year 2018-19. As per the letter read as 2<sup>nd</sup> paper above, the Member Secretary, KSRRDA has submitted necessary proposal for the release the balance central share of ₹47.75 crores from the H/A 2515-00-800-74-01 and the state share of ₹65.17 crores from the H/A 2515-00-800-74-02 respectively.

2. Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹47.75 Crore(Rupees Forty Seven Crore and Seventy Five Lakh only) as the balance of Central Share of 1<sup>st</sup> installment of Programme Fund and ₹65.17 Crores(Rupees Sixty Five Crore and Seventeen Lakh only) towards the 1<sup>st</sup> installment of State Share of Programme Fund under PMGSY for the Year 2018-19 from the current year's Budget Provision under the h/a 2515-800-74-01 and 2515-800-74-02 respectively.
