**ORDER**

The Ministry of Rural Development, Government of India is rolling out the Young Professional Scheme in National Rurban Mission (NRuM). As per Government Order read above, sanction was accorded for the placement of Sri. Karthik R. and Ms.Reshma S. Varghese as Young Professionals for the successful implementation of different activities under National Rurban Mission in the State for a period of one year with a consolidated pay of Rs. 40,000/- per month.

2. Sri.Karthik and Ms.Reshma S. Varghese were joined duty in Commissionerate of Rural Development on 02.05.2018 F.N. Therefore the term of contract period expired on 01.05.2019 A.N. The Commissioner for Rural Development, as per his letter read as 3<sup>rd</sup> paper above, has reported that the implementation of National Rurban Mission Phase I project is nearing completion and Phase II & III have just started. Moreover the MIS data entry of the projects has also to be done in a time bound manner. Therefore, the service of the Young Professionals is inevitable for a further period of one year for providing support for the clusters as well as State Nodal Agency. The Young Professionals are also requested to extend their contract period for one more year.

3. The Commissioner for Rural Development has further reported that a mid term evaluation has been conducted as instructed in the Government Order read above and the Performance Report of the Young Professionals Shri. Karthik R and Ms.Reshma

S. Varghese were furnished to Govt. It is reported therein that, the service of the individuals during the contract period was found satisfactory and they performed their duties appreciably well and also reported that both of them are hardworking, performing their duties commendably and maintains good attitude and inter personal relation with the people in SNA, MoRD, SPMU and CDMU. The State Level Empowered Committee for National Rurban Mission held on 28.12.2018 has inter-alia decided to extent the contract period of the Young Professionals for one year and to enhance their remuneration by 10%. Therefore the Commissioner for Rural Development has requested permission to extent the contract period for one more year with remuneration of Rs. 44,000/- per month.

4. In the above circumstance, Government are pleased to accord sanction to extent the contract period of Sri.Karthik R. and Ms. Reshma S. Varghese as Young Professionals in the National Rurban Mission for one more year w.e.f 02.05.2019 FN with a consolidated pay of ₹44,000 (Rupees Forty Four Thousand only) per month, subject to the terms and conditions No.1-12 mentioned in Government Order read above.
