ORDER

The Chief Engineer, Local Self Government Department, as per the letter read as 3rd paper above has forwarded a proposal for extension of probation in respect of Sri.Pramod Kumar K.P., in the cadre of Assistant Engineer. The incumbent was recruited in the Municipal Common Service as Overseer Grade II, subsequently promoted as Overseer Grade I and later provisionally promoted to Assistant Engineer as per the proceedings read as first paper issued by the Municipal Director and joined duty on 24.01.2002 FN. He was later absorbed to LSG Engineering Wing. The incumbent retired from Service on 31.05.2015.

2. Sri.Pramod Kumar K.P. has not passed the obligatory departmental tests during the normal period of probation in the cadre of Assistant Engineer. But he has attained the age of 50 years on 11.05.2009, as his date of birth is 12.05.1959. Therefore he can be exempted from passing the obligatory departmental tests and his probation has to be extended up to 13.05.2009 AN so as to declare his probation on 12.05.2009 FN. The CE has extended his probation up to 04.04.2005 as per the proceedings read as 2nd paper above, considering the period of 70 days of HPL availed by the incumbent and requested Government for a further extension up to 13.05.2009 AN, as per the letter read as 3rd paper above.

3. Government have examined the matter in detail and are pleased to

regularise the provisional promotion ordered in respect of Sri.Pramod Kumar K.P., in the cadre of Assistant Engineer w.e.f. 24.01.2002 FN and his probation period in the above cadre is hereby extended from 05.04.2005 up to 13.05.2009 AN as per Rule 21 of Part II KS & SSRs, 1958.
