ORDER

As per the Sanction Orders read as 3rd paper above, Government of India have sanctioned the grant-in-aid amount of Rs.24,14,00,000/- (General), Rs.14,00,12,000/- (SCP), Rs.10,13,88,000/- (TSP) respectively towards the 2nd installment of Central Share for implementation of placement linked Skill Development Project for 71200 candidates under DDU-GKY approved in Action Plan 2016-19 by Kudumbashree, Kerala SRLM. As per the Government Order read as 2nd paper above, sanction has been accorded to release the aforesaid General & SCP components of Central and State Shares of DDU-GKY to Kudumbasree. Due to lack of sufficient fund under the Head of Account 2501-06-796-99 during 2018-19, the Central and State Shares of TSP component was not released. As per the letter read as 4th paper above, the Executive Director, Kudumbasree has reported that Central and State Share of General and SCP Component amounting to Rs. 63,57,13,000/- sanctioned as per G.O. read as 2nd paper above was not credited to the Account of Kudumbasree during the Financial year 2018-19.

After having examined the matter in detail, Government are pleased to accord sanction to release a total amount of Rs.40,23,50,000/- towards IInd Installment of Central and State Share of General, SCP and TSP Component for implementation of placement linked Skill Development Project for 71200 candidates under DDU-GKY approved in Action Plan 2016-19 by Kudumbashree, Kerala SRLM for the year 2018-19 from the current year's Budget provision as detailed below,

subject to the condition that the further release of funds will be effected with the submission of Utilization Certificate for the below amount.
