ORDER

As per the G.O read as 3rd paper above Government have accorded Administrative Sanction for an amount of **Rs.1703 lakh** under the **H/A 2515-00-101-68** and **Rs.2305 lakh** under the **H/A 2217-80-800-71** for the implementation of various components of Plan Schemes of Suchitwa Mission under Suchitwa Keralam (Rural) and Suchitwa Keralam (Urban) respectively, for the Financial Year 2019-20.

2.As per circular read as 1st paper above Administrative Sanction for the plan schemes for the year 2019-20 shall be issued only after deducting Treasury queue bill amount for the year 2018-19(if any) from the current year's budget provision .

3.. As per the letter read as 2nd paper above Executive Director Suchitwa Mission has reported that, bill for an amount of **Rs.250 Lakh** for the year 2018-2019 is pending as on 31.03.2019 under **H/A 2217-80-800-71 Suchitwa Keralam (Urban)**.

Government have examined the matter in the light of the circular read as 1st paper above and are pleased to issue revised Administrative Sanction for the following plan scheme of Suchitwa Mission - "**Suchitwa Keralam (Urban)**" for an amount of **Rs. 2055 Lakh under H/A 2217-80-800-71** as detailed below,after deducting the queue bill amount of Rs. 250 Lakh, from the amount of Rs. 2305 Lakh, for which Administrative Sanction has been accorded as per GO read as 3rd above for the implementation of various components under Suchitwa Keralam (Urban).
