**ORDER**

As per the G.O read as 1st paper above, Government have accorded sanction to include certain grama panchayats coming under the Notified Planning areas of TRIDA, GCDA & Goshree Island Development Authority under PMAY(U) and to designate the development authorities concerned as nodal agencies for implementation of PMAY(U) in the planning area under their jurisdiction. The Central Sanctioning and Monitoring Committee meeting of Ministry of Housing & Urban Affairs has approved the DPR's of grama panchayats falling under the development authorities to the tune of Rs 14204 lakh for the construction of 3551 dwelling units.

2. The beneficiaries approved under LIFE Scheme in the respective panchayats were included in the DPR so as to avail additional central assistance of Rs 1.5 lakh/beneficiary.

3. As per the letter read as 2nd paper above, the Executive Director, Kudumbasree has requested to accord sanction to transfer the central share for beneficiaries in the grama panchayats falling under the planning area of development authorities to LIFE Mission for onward transfer to urban local bodies along with proportionate state share.

4. Government have examined the matter in detail and are pleased to accord sanction to Kudumbashree to transfer the central share of fund along with proportionate state share for the implementation of the above said scheme to LIFE Mission for onward transfer to the concerned grama panchayats.
