

Finance Department - Budget Estimates 2019-2020 – Fund for Expansion and Development – Authorization of shortfall in the amount of Performance Grant under 14th Finance Commission Grant to Urban Local Governments for the Financial Year 2017-18 - Sanctioned - Orders issued.

<u>ORDER</u>

An amount of ₹126,20,81,211/- has been authorized to 58 eligible Municipalities and 4 eligible Municipl Corporations as Performance Grant under 14th Finance Commission Grant for the Financial Year 2017-18, vide Government Order read as 1st paper above.

2) Government of India imposed a condition that Local Bodies which were newly constituted after 2014-15 shall not be eligible for Performance Grant during the award period of 14th Finance Commission. FC Grant is given to Local Governments as a part of Development Fund. All Local Governments have more or less same basic service requirements. Hence the benefit of FC Grant is to be extended to all Local Government which provide basic service to their citizens. Considering these facts the HLMC meeting held on 01.08.2018 decided to provide Performance Grant to all eligible Local Governments including newly constituted LGs. A list comprising of ULBs eligible for Performance Grant for the FY 2017-18 as well as those ineligible for the same was furnished to the Ministry of Housing and Urban Affairs, Government of India by the State. Even though the State furnished a list of 90 ULBs consisting of 6 MCs and 84 Municipalities as eligible for Performance Grant for the FY 2017-18, the 14th FC Support Cell of National Institute of Urban Affairs have found only 51 ULBs consisting of 4

Municipal Corporations and 47 Municipalities as eligible for Performance Grant for the FY 2017-18.

3) Government of India, vide letter read as 3^{rd} paper above, have conveyed the sanction for the release of ₹162.63 Crore as Performance Grant under 14^{th} Finance Commission Award to Urban Local Bodies for the FY 2017-18 to the State of Kerala. In this circumstance, an amount of ₹67,61,02,277/- has to be authorized to 4 Municipal Corporations and 41 Municipalities which are found eligible for Performance Grant for the FY 2017-18 as shortfall, as the amount due to some of them has varied /not authorized as per the list received from GoI. Based on the same the following orders are issued:

a) Authorization of shortfall in the amount of Performance Grant under 14th Finance Commission Award for the FY 2017-18 amounting to ₹67,61,02,277/- (Rupees Sixty Seven Crore Sixty One lakhs Two thousand Two hundred and Seventy Seven only) is issued to 4 eligible Municipal Corporations and 41 eligible Municipalities as balance amount of Performance Grant for the FY 2017-18 as detailed below:

- b) With this authorization and the authorization issued vide Government Order read as 1st paper above, Government have complied with the directions of Government of India on the release of Performance Grant to eligible Urban Local Governments for the FY 2017-18.
