ORDER

An amount of Rs. 50 lakh has been earmarked in the current year's budget provision under the head of account 2217-80-003-96 for the scheme "Implementation of Accounting reforms in newly created Urban Local Governments (new scheme)". The Departmental Working Group held on 06.06.2019 considered the above proposal and approved the same. The Departmental Working Group has also approved the qualification and remuneration of the employees to be appointed for the scheme on contract basis.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the scheme "Implementation of Accounting reforms in newly created Urban Local Governments (new scheme)" for an amount of Rs. 50 lakh under Head of Account 2217-80-003-96 for the Year 2019-20. Sanction is also accorded to appoint Accounts Officer, IT Officer and Accounts Assistant on contract basis for a period of six months for the implementation of the scheme with the qualification and remuneration mentioned below, subject to the condition that no extension will be allowed for the project.
