### **ORDER**

An amount of Rs.70 Lakh has been earmarked in the State Budget 2019-20 under the Head of account '2515-00-001-44-Modernisation and Strengthening of e-Governance initiatives in Rural Development -34-other charges-3 other items'. It is an ongoing Scheme which aims to modernise the Commissionerate of Rural Development (CRD). The components of the scheme include modernisation, maintenance and procurement of equipments, replacement of vehicles/hiring of vehicles at the Commissionerate, District level offices and other offices that comes under the CRD. But the proposal for 'Modernisation and Strengthening of e-Governance initiatives in Rural Development Department' submitted by the CRD before the Working Group included the component 'Setting up of record room in Commissionerate of Rural Development' also.

- 2. The Departmental Working Group meeting held on 08.08.2019 also approved the component 'Setting up of record room in Commissionerate of Rural Development', though it was not included in the Plan write up, for an amount of Rs.14 Lakh.

In the circumstances, Government are pleased to accord administrative sanction for the component 'Setting up of record room in Commissionerate of Rural Development' under the Plan Scheme 'Modernisation and strengthening of e-governance initiatives in Rural Development Department' for an amount of Rs.14 lakh. The expenditure shall be debited to the head of account '2515-00-001-44-Modernisation and Strengthening of e-Governance initiatives in Rural Development -34-other charges-3 other items'.
