# <u>O R D E R</u>

The 14<sup>th</sup> Finance Commission has recommended an amount of ₹2338.55 crore as Finance Commission Grant to Local Governments for the year 2019-20. Out of this, an amount of ₹879.42 crore has been earmarked as Basic Grant to Urban Local Governments (ULGs - Municipalities and Municipal Corporations).

2) As per Government Order read as 3<sup>rd</sup> to 5<sup>th</sup> papers above, 1<sup>st</sup> installment of Basic Grant as released by the Government of India amounting to Rs.439.71 crore have been authorized to Urban Local Governments.

3) Government of India, vide letter read as  $6^{th}$  paper above, have released an amount of ₹439.71 crore as  $2^{nd}$  installment of Basic Grant under  $14^{th}$  Finance Commission Award to ULGs for the year 2019-20.

4) Under these circumstances, the following orders are issued:

a) Authorization for 2<sup>nd</sup> installment of Basic Grant under14<sup>th</sup> Finance Commission Award 2019-20 amounting to ₹439,71,00,000/- (Rupees Four hundred and Thirty Nine crore Seventy One lakh only) is issued to the Urban Local Governments as detailed below:
