ORDER

As per Government Order read as 1st paper above, Dr. Abey George, Associate Professor, KILA was appointed as Director of Mahatma Gandhi NREGA Social Audit Society Kerala on deputation basis for a period of three years. The Director, KILA as per letter read as 2nd paper above has requested Government to repatriate Dr. Abey George from MGNREGA Social Audit Society and allow him to join KILA urgently as his service is essential in KILA since there is acute shortage of teaching faculty in the Institute.

- 2) Accordingly, as per Government Order read as 3rd paper above, the deputation of Dr.Abey George, Associate Professor, KILA as Director, MGNREGA. Social Audit Society was terminated and directed him to report back to KILA. Dr.Abey George has filed WP(C) No.33375/2019 before the Hon'ble High Court challenging the above Government Order. The Hon'ble High Court as per judgment read as 5th paper above has set aside the G.O. read as 3rd paper above and made clear that the respondents would be free to pass fresh orders in accordance with Ext.P5 (relevant page of the Annual Master Circular of MGNREGA 2019-20) as well as on the basis of the minutes of the Governing Body of MGNREGA Social Audit Society dated 18.01.2020 (Ext.R1(b)).
- 3) As per para 10.1.4.1 (f) of the Annual Master Circular 2019-20 of MGNREGA (Ext.P5), issued by the Minisitry of Rural Development, Government of India, any decision to terminate the services of the Director, Social Audit Unit

prematurely shall be taken by the Government of the State only after consultation with the Governing Body. As stipulated in the Master Circular, the request of Director, KILA to repatriate Dr.Abey George from MGNREGA Social Audit Society and to allow him to join his parent Department i.e. KILA was taken up with the Chairman, Governing Body of MGNREGA Social Audit Society for consideration. Accordingly, the Governing Body of MGNREGA Social Audit Society held on 18.01.2020 discussed the matter and took note of the request of Local Self Government Department seeking his repatriation from MGNREGA Social Audit Society.

- 4) The Government have now completed the process of consultation with the Governing Body of MGNREGA Social Audit Society.
- 5) In the circumstance, Dr.Abey George, Director, MGNREGA Social Audit Society is repatriated with effect from the A.N. of 27.02.2020 to KILA and his services are placed at the disposal of Director, KILA. The powers of the Director, MGNREGA Social Audit Society is delegated to Sri. E. Sreekumar, Social Development Specialist with effect from 28.02.2020 F.N., as per the Rules and Regulations (No.8) of the Mahatma Gandhi NREGA Social Audit Society.
- 6) Judgment dated 18.02.2020 of the Hon'ble High Court of Kerala in WP(C) No. 33375/2019(V) read as 5th paper above is complied with accordingly.
