ORDER

Government of India vide letter read as 1st paper above have released an amount of Rs.396,89,11,000/- (Rupees Three Hundred Ninety six Crore Eighty Nine Lakh and Eleven Thousand Only) to the State Government of Kerala being the 1st installment of 1st tranche of central assistance towards material and administrative contingency for implementation of MGNREGA for the financial year 2020-21. The Mission Director(MGNREGS) vide letter read as 2nd paper above, has submitted a proposal for release of Central Share received along with the corresponding state share. As there was no component-wise bifurcation for the central release, the Mission Director submitted the proposal for release of funds based on requirement.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs.396,89,11,000/ (Rupees Three Hundred Ninety six Crore Eighty Nine Lakh and Eleven Thousand Only) being the 1st installment of 1st tranche of Central Assistance received towards material and administrative components for implementation of MGNREGA for the financial year 2020-21 along with the corresponding state share of Rs.108,96,37,000/-(Rupees One Hundred and Eight Crore Ninety Six Lakh Thirty Seven Thousand only)- towards
