ORDER

The Hon'ble Kerala Administrative Tribunal , as per the order dated 25.04.2018 in OA No.2818/2016 filed by Dr.Samji David disposed of the O.A. with a direction to the 1st respondent to consider Annexure A 31 representation expeditiously with notice to the applicant, within three months from the date of receipt of a certified copy of the order. Aggrieved by the non compliance of the order dated 25.04.2018 in OA No.2818/2016, the applicant filed OP (KAT) 418/2018. The Hon'ble High Court, as per the judgment dated 04.01.2019 disposed of the O.P. with liberty to the petitioner to move the Tribunal appropriately in case he is aggrieved by the non compliance with the direction of the Tribunal in the matter of consideration of Annexure A31 representation.

2. Annexure A 31 representation is the request of the applicant to consider him for promotion and to restore his seniority from 2004 on wards.

3. Memo of charges was issued to the applicant in relation to a loss of Rs.17 lakhs sustained by the Government in relation to the installation of an incinerator at Kayamkulam Municipality. Another Memo of Charges was issued to the applicant in relation to the loss suffered by the Government to the tune of Rs.4 lakhs in the implementation of project of paving, metaling and tarring of bus stand yard and its approach road in Kalpatta Municipality during the year 2002-2003. The said memo of charges are for the imposition of major penalty. The disciplinary cases are not yet finalized.

4. Government have examined the matter in detail. The applicant was not considered for promotion to the post of Municipal Secretary Grade II by the Departmental Promotion Committee (Higher), since disciplinary action was pending against him. In the circumstances, Annexure A 31 representation is hereby rejected and the order dated 25.04.2018 in OA No.2818/2016 filed by Dr.Samji David is complied with accordingly.
