ORDER

As per the G.O read as 1^{st} paper above, Administrative Sanction was accorded for the project "Sewage Treatment Plant – Kureepuzha" being implemented by KWA in Kollam Corporation for Rs 30 Crore. The 23^{rd} SHPSC of AMRUT held on 4/2/2020 had accorded sanction for revision of AS for the project subject to approval of Corporation Council. The DPR for the work was also prepared by KWA.

Reason for Revision

The lowest bid amount was Rs.26,99,00,000 which was 12.84% above Tendered PAC. KWA Board held on 27.01.2020 resolved to award the work at Local Market Rate (LMR) of Rs.25,96,84,679 (8.57% above Tendered PAC).

- 2. As per the letter read as 3rd paper above, the Mission Director AMRUT has reported that the additional fund requirement shall be met from the work "Septage Treatment Plant at Vasoorichira" which is proposed to be cancelled by the Council.
