**ORDER**

The DPC(H) 2019 held on 06.12.2018 superseded Sri. Babu Chinnappan, Executive Engineer for promotion to the post of Superintending Engineer due to the prevalence of disciplinary action for major penalty against him in Govt file no.EW2/300/2015/LSGD.

2. Later the said disciplinary action was finalised by absolving him of charges vide GO(Rt) no.1547/2019/LSGD dtd 23.07.2019. In the meantime, he expired while in service on 28.07.2019. Thereafter, the Review DPC(H) held on 17.03.2020, considered the eligibility of the incumbent for inclusion in the select list 2019 for promotion to the post of Superintending Engineer and decided to place him as Sl no.3(a) just below Smt. V. D. Jalajamony and just above Sri. Rejeevan C. Based on the DPC decision, the modified select list 2019 was notified vide GO read as 2<sup>nd</sup> paper above.

3. Sri. Rejeevan C. who was included as Sl no.4 and Rank no.10 in the modified select list 2019 and the immediate junior to Babu Chinnappan was regularly promoted as Superintendent Engineer vide GO read as 1<sup>st</sup>

paper above. Accordingly, the Chief Engineer, vide letter read as 3<sup>rd</sup> paper above has proposed to promote Late Babu Chinnappan notionally to the cadre of Superintending Engineer w.e.f date of promotion of his immediate junior, ie 22.07.2019.

4. In the above circumstances, Government are pleased to notionally promote Late. Babu Chinnappan to the cadre of Superintending Engineer w.e.f the date of promotion of his immediate junior, ie 22.07.2019, without monetary benefit of back arrears of pay and allowances.
