### **ORDER**

As per G.O read as  $1^{\text{st}}$  paper above. Government have accorded sanction for availing a loan amount of Rs.550 Crore from HUDCO through KURDFC for the project of Life Mission by restructuring the State share to Phase II Rural Sector. The repayment of  $1^{\text{St}}$  quarterly instalment of principal amount was sanctioned vide G.O read as  $2^{\text{nd}}$  paper above.

- 2. As per letter read as  $3^{rd}$  paper above Managing Director, KURDFC has requested for the release of  $2^{nd}$  instalment of principal amount to the tune of Rs.9,16,66,667/- and also to transfer-credit the amount to the Escrow Account maintained by KURDFC.

As per letter read as 4<sup>th</sup> paper above CEO, LIFE Mission has also requested to accord sanction to release the 2<sup>nd</sup> instalment of principal amount of Rs. 9,16,66,667/-(Rupees Nine Crore Sixteen Lakh Sixty-six thousand Six hundred and sixty seven only) from the budget head of account 4515-00-102-49(Plan-voted) and to transfer -credit the amount to the Escrow Account maintained by KURDFC out of current financial year budget provision of Rs.410.41 Crore.
