**ORDER**

As per letters read as 1st & 2nd above, Government of India sanctioned 1st and 2nd instalment of Central Share during the year 2019-20 for the implementation of IWMP projects under Watershed Development Component of Pradhan Manthri Krishi Sinchayee Yojana (WDC-PMKSY). But due to the shortage of sufficient balance in the Budget provision, entire amount of Central share and corresponding State share was not released. In the circumstances, the Commissioner for Rural Development Department & the Chief Executive Officer of SLNA, as per the letter read as 5th paper above, has submitted proposal for the release of the balance amount.

2.As per Government order read as 6th paper above, an amount of ₹26,61,30,000/- has been additionally authorised for meeting the requirement towards the utilisation of Central assistance and its corresponding State share under Pradhan Mantri Krishi Sinchayee Yojana.

3. In the above circumstances Government are pleased to accord sanction to release an amount of ₹38,86,20,000/- (Rupees Thirty Eight Crore Eighty Six Lakh and Twenty Thousand only) as detailed below;
