ORDER

- Sri. Anilakumaran C., Asst.Exe.Engineer has filed OA (E) 1588/2020 before the Hon'ble Kerala Administrative Tribunal praying for a direction to promote him as Exe.Engineer in accordance with the seniority position in the combined seniority list of Asst.Engineer.
- 2. The Hon'ble Kerala Administrative Tribunal, as per its order read as Ist paper above, has directed the respondents to issue appropriate orders promoting the applicant to the post of Exe.Engineer provisionally as expeditiously as possible, at any rate, within a period of three weeks from the date of receipt of a copy of the order, subject to further orders to be issued in the OA.
- 3. The Chief Engineer, vide letter read as 2nd paper above, has reported the applicant has been included as Sl.No.48 in the select list 2012 for promotion to the post of Asst.Exe.Engineer. His junior, Sri. Girish R. D., who has been included as SL No. 51 in the select list 2012, has been promoted as Executive Engineer vide GO (Rt) no. 829/2020/LSGD dated 05.05.2020. Hence, the Chief Engineer has recommended that in compliance with the KAT direction, the applicant, who is due to retire from service on 31.05.2021, may be granted provisional promotion to the cadre of Executive Engineer.
- 4. In the above circumstances, Sri. Anilakumaran C., Asst.Exe.Engineer is provisionally promoted to the cadre of Executive Engineer as per Rule 31 (a) (I) of Part II of KS&SSRs, 1958 in the pay scale of Rs 68,700-1,10,400/- subject to the final orders of the Hon'ble Tribunal in OA(E) 1588/2020, and posted as such in PIU,
