**ORDER**

As per letters read as 1<sup>st</sup> & 2<sup>nd</sup> above, Five Asst. Engineers namely Sri. Mahesh T. S., Smt. Aruna V., Smt. Shalini S., Sri. Sumesh V. M. and Sri. Shamnad J. from the LSGD Engineering Wing were selected for the M Tech Course in Translational Engineering, at the Government Engineering College, Barton Hill, Thiruvananthapuram, for the academic year 2019-21 as Government sponsored candidates. As per the Proceedings read as paper 3<sup>rd</sup> above, the Chief Engineer, LSGD relieved the incumbents to join the Course. As per GO read as 5<sup>th</sup> paper above, sanction was accorded to the Chief Engineer, LSGD to draw and release an amount of Rs 2,40,750/- to meet their tuition fee for the 1<sup>st</sup> semester.

2. The Chief Engineer, LSGD, vide letter read as 6<sup>th</sup> paper above has requested to release the tuition fee for 2<sup>nd</sup> and 3<sup>rd</sup> semester of the above five Asst. Engineers amounting to Rs 4,80,450/- (2<sup>nd</sup> semester fee - Rs 2,32,500 (46,500 x 5)) (3<sup>rd</sup> semester fee - Rs 2,47,950/- (Rs 49,590 x 5)) (Rupees Four lakh Eighty thousand four hundred and fifty only). Out of the budget allocation of Rs 9 lakhs in the head of account "2515-00-001-91-34-3-other charges(NP)" towards the course fee in the

current year, only Rs 2,40,750 has been expended so far.

Government have examined the matter in detail and are pleased to accord sanction to the Chief Engineer, LSGD to draw and release an amount of Rs 4,80,450/- (Rupees Four lakh Eighty thousand four hundred and fifty only) under the head of account ' 2515-00-001-91-34-other charges-3-other items(NP)' to meet the tuition fee for the 2<sup>nd</sup> and 3<sup>rd</sup> semesters in respect of of five Asst.Engineers namely Sri. Mahesh T. S., Smt. Aruna V., Smt. Shalini S., Sri. Sumesh V. M. and Sri. Shamnad J. of LSGD Engineering Wing, attending M.Tech Course in Translational Engineering for the year 2019-21, at Govt Engineering College, Barton Hill, under sponsored category.
