ORDER

As per the G.O read as 2nd paper above, Government have accorded sanction for the implementation of World Bank assisted Kerala Urban Service Delivery Project (KUSDP) for providing additional financial and technical support for effective waste management, septage and sewage management in sanitation sector of all Urban Local Bodies(ULBs) and selected Panchayats adjoining ULBs.

As per G.O read as 3rd paper above, Government have accorded sanction for the continuation of the Project Management Unit of Kerala Local Government Service Delivery Project (KLGSDP), a closed World Bank project, in aid of preliminary works for KUSDP with permission for retention of skeleton three staff members of KLGSDP in the Project Management Unit. As per G.O read as 4th paper above name of the Project i.e. Kerala Urban Service Delivery Project (KUSDP) has been changed as Kerala Solid Waste Management Project (KSWMP). As part of the retention of three staff members of KLGSDP in the Project Management Unit of KUSDP, service of Shri. Pravaeen K., Office Attendant, KLSGDP has been retained for carrying out preparatory activities of KSWMP. As per G.O read as 1st paper above,

an amount of Rs. 18000/- was fixed as consolidated pay for Shri. Praveen K. and the same has not been revised till date. As per the letter read as 5th paper above, the Project Director, KSWMP has recommended to enhance the consolidated pay of Shri. Praveen K., Office attendant, KSWMP from 18,000/- to 24,000/- (with hike of 33%)

The total project cost of KSWMP is 300 million US Dollar, out of which 210 million US Dollar is to be financed by the World Bank and the remaining 90 million US Dollar will be provided from State budget. The establishment expenses of the Project is reimbursable from the World Bank share.

Government have examined the matter in detail and are pleased to accord sanction for the enhancement of consolidated pay of Shri. Praveen K., Office Attendant, Kerala Solid Waste Management Project (KSWMP) from Rs.18,000/- to **Rs.24,000/- (Rupees Twenty Four Thousand Only)** w.e.f 01.01.2021
