### **ORDER**

As per the order read as 1st paper above, Administrative Sanction was accorded for the work, "Sewage Treatment Plants at Karukodi & Sundaram Colony" (SAAP 2016-17) under Sewerage & Septage sector, being implemented by the Palakkad Municipality.

- 2. As per the letter read as 3rd paper above, the Mission Director, AMRUT has informed that the quote received in the 5th tender call after negotiation was 18.51% above Tendered Probable Amount of Contract (TPAC). The Technical Sanction (TS) was accorded for Rs.9.20 Cr. (Tendered Probable Amount of Contract (TPAC) Rs.7.43 Cr. + Road Restoration Rs.1.66 Cr. + Utility Shifting Rs.0.10Cr.).
- 3. The Mission Director has also informed that an excess amount of Rs.1.37 Cr. over the Tendered PAC is required due to tender excess of 18.51% and the additional fund requirement of Rs.1.37 Cr. will be met from the savings in Administrative Sanction of the same project.
- 4. Government have examined the matter in detail and, based on the decision of the 26th SHPSC(No.5.12), are pleased to accord sanction of tender excess of 18.51% for the work "Sewage Treatment Plants at Karukodi & Sundaram Colony" (SAAP 2016-17) under Sewerage &
