# **ORDER**

As per the Government order read as 1<sup>st</sup> paper above, sanction was accorded for the release of an amount of ₹8,82,96,666/- (TSP Component) towards the part payment of the 1<sup>st</sup> installment of the Central and State Share for implementation of the NRLM for the year 2020-21. After issuing the Government order, Kudumbasree was able to get released only Rs. 7,74,96,240/-, as there is a shortage of Rs.1,08,00,426/- in the Head of Account 2501-06-796-99.

- 2)As per the Government Order read as 3<sup>rd</sup> paper above sanction was also accorded for the release of an amount of ₹10,90,98,333/- (General Component) and ₹12,80,70,000/- (SCP Component) to Kudumbashree towards the balance payment of 1<sup>st</sup> Installment of Central Share and the matching State Share for implementation of the NRLM for the Year 2020-2021.
- 3)As per the letter read as  $2^{nd}$  paper above the Ministry of Rural Development, GOI have sanctioned an amount of ₹5,29,78,000/- (TSP Component) balance payment of  $1^{st}$  Installment of Central Share for

implementation of the NRLM for the Year 2020-2021. While issuing the Government order read as  $3^{rd}$  paper above, Government have not released the Central share of \$5,29,78,000/- as well as the corresponding State share of \$3,53,18,666/- due to the the non availability of sufficient fund in the Head of Account 2501-06-796-99.

- 4)Now the Executive Director, Kudumbashree, as per his letter read as 4<sup>th</sup> paper above, has requested to accord Administrative Sanction to release the above pending releases amounting to ₹9,90,97,092/- in the year 2020-21.
- 5)After having examined the matter in detail, Government are pleased to accord sanction to release a total amount of ₹9,90,97,092/- (Rupees Nine Crore Ninety Lakhs Ninety Seven Thousand and Ninety Two only) towards the pending release of TSP component of Central & State share for the implementation of NRLM/Aajeevika in the State of Kerala by Kudumbashree, Kerala SRLM for the financial year 2020-21 as detailed below:
