ORDER

As per the decision of 30th meeting of State Level Advisory Committee (SLAC) for waste management held on 19.10.2019, Kerala State Industrial Development Corporation (KSIDC), the nodal agency for the establishment of Waste to Energy Projects in the State, has floated e-tender for the development of Integrated Solid Waste Management project with a Waste to Energy plant of 20 TPD capacity at Munnar in DBFOT basis under Public Private Partnership mode. As no bids received in the first tender process, as per the decision of the 32nd meeting of SLAC, KSIDC retendered the project and Consortium of M/s Al Bucheeri General Transport Est Pathanamthitta, M/s Al Bucheeri Transporting Est, UAE and M/s Organic Recycling Systems Pvt Ltd, Mumbai has submitted bid for the project.

As per the letter read above, the Managing Director, KSIDC has reported that the Bid Evaluation Committee meeting chaired by Secretary, Power Department held on 19/08/2020 carried out the detailed technical evaluation of the bid in the presence of representatives from the consortium. The Bid Evaluation Committee after detailed deliberations resolved to consider the bid as technically qualified and recommended to open the financial bid submitted by the Consortium for the project and as per financial bid submitted, the Tipping fee quoted for the setting up of Integrated Solid Waste Management Project with a Waste to Energy plant at Munnar is Rs.6500/- per tonne. Managing Director, KSIDC has requested to constitute a Negotiation Committee to carry out negotiation of the Tipping Fee with the bidder for Munnar Waste to Energy Project.


