## <u>ORDER</u>

As per letter read as 4<sup>th</sup> and 5<sup>th</sup> paper above, Managing Director, KURDFC and CEO, LIFE Mission has requested to accord sanction to release the 3<sup>rd</sup> instalment of principal amount to the tune of Rs. 9,16,66,667/-(Rupees Nine Crore Sixteen Lakh Sixty-six thousand Six hundred and sixty seven only) and to transfer-credit the amount to the Escrow Account maintained by KURDFC [Account No.37920881126 (Rural out), IFS Code: SBIN0070033, State Bank of India, Vazhuthacaud Branch] from the budget head of account 4515-00- 102-49 (Plan-Voted) Rural, out of current financial year budget provision.
