ORDER

PMAY(G) has been emerged as the flagship programme for the Central Government as well as the State Government. The scheme aims to achieve the target 'housing for all' by the year 2022. To attain this target, a co ordinated monitoring at different levels is highly essential. As the State and District level monitoring committees have a pivotal role as an important instrument in this respect ,its effective functioning and supervision are imperative—to make the programme a success. As per the Annual Action Plan (AAP) of PMAY(G) mentioned in para 3.6 of Chapter-3, the States/UTs shall constitute Committees both at the State and District Level for Direction and oversight.

- 2.The Committees shall comprise of officials implementing different components of the Annual Action Plan and public representatives. The State Level Committees shall be chaired by the Chief Secretary and District Level Committee shall be chaired by the District Collector. The composition of the Committee at the State and District Level can be decided by the State Government. The State Level Committee shall meet at least twice a year while the District Level Committee shall meet every quarter in a year. As such the Committees have to be constituted for serving the purpose.
- 3.Government have examined the matter in detail and are pleased to constitute State and District Level Monitoring Committees of PMAY (G) as follows:
