ORDER

As per the Government order read as 1st paper above, Government have designated Department of Town & Country Planning as the State Level Nodal Agency and Chief Town Planner(Planning) as the State Level Nodal Officer for the preparation of the Scheme 'Formulation of Local Area Plan and Town Planning Scheme.'

2. The wards Vizhinjam, Mulloor, Kottapuram & Venganoor have been selected as the scheme area for the preparation of Town Planning Scheme and the wards Palayam, Thampanoor, Vazhuthacaud and Thycaud have been selected for the preparation of the Local Area Plan in Thiruvananthapuram.

3. The CTP has stated that the scheme areas have to be surveyed by UAV/Drone, for preparing land-use maps and requested for permission for conducting the aerial survey using drone in the areas where Scheme of Formulation of Local Area Plan & Town Planning Scheme has been conducted.

4. Government have examined the matter in detail and are pleased to constitute a Committee comprising of following members for monitoring and supervising the survey at the Special Security Zone since the survey using drone in the areas as part of Scheme of Formulation of Local Area

Plan & Town Planning Scheme includes movement of a drone in restricted areas and taking of photographs/videos of special security zone areas.

- Mission Director AMRUT - Member
- City Police Commissioner - Member
- ADGP (Intelligence) [State Special Branch - SSB] - Member

5. The Committee shall entrust an agency for the drone survey and they should ensure the security of the installations and to keep the confidentiality of the content obtained through the survey during and after the processing period and also the agency conducting drone survey must give directions to give special care when surveying the areas having Central Government Institutions.


